SECTION A: INSTRUCTIONS FOR PRE-QUALIFICATION

1.1 Introduction

The **Kenya Law Reform Commission (the Commission)** is established by the Kenya Law Reform Commission Act, No. 19 of 2013 (the Act). The Commission has a statutory and ongoing role of reviewing all the laws of Kenya to ensure that they are modernized, relevant and harmonized with the Constitution of Kenya.

The Commission invites eligible candidates to prequalify as suppliers of goods, services and works for the period ending 30th June 2017.

Vision

"A vibrant agency for responsive law reform"

Mission

"To facilitate law reform conducive to social, economic and political development"

The Commission intends to prequalify suppliers and contractors for the supply of goods, works and services for the financial year 2016 -2017. Suppliers registered with registrar of companies under the Laws of Kenya in respective merchandise or services are invited to submit prequalification documents to the Secretary/ CEO, Kenya Law Reform Commission so that they may be shortlisted. Please read through the document carefully and provide the requested information together with all supporting documents.

Note: For those who were successfully pre-qualified last financial year 2015-16 do not need to be pre-qualified again unless there is change and interests of the firm

- 1.2 Candidates must qualify by meeting the set criteria to perform the contract of supply delivery and provision of goods, works and services to the Commission. Suppliers who are not prequalified or fail to meet the prequalifying criteria will not be allowed to participate in the Tenders/RFQs/RFPs

Prospective suppliers and contractors must have carried out successful supply and delivery of similar items / services to other institutions (This does not apply to youth and disabled). Potential candidates must demonstrate the willingness and commitment to meet the pre-qualification criteria.

The document includes questionnaires for s and instructions for prospective suppliers. In order to be considered for pre-qualification, prospective suppliers must provide requested proof and all other information requested.
